

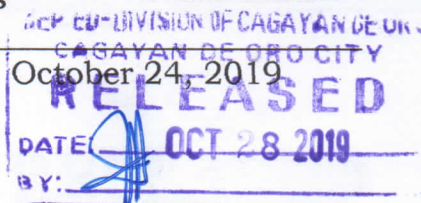



**SUBJECT:** *National Online Survey on the Development of Competency Framework for Non-Teaching and Related-Teaching Positions*

**DATE:** 11 October 2019

As part of ongoing efforts to strengthen the agency's human capital and align its strategic HR systems, the Bureau of Human Resource and Organizational Development-Human Resource Development Division (BHROD-HRDD) began the development of competency frameworks for DepEd non-teaching and related-teaching positions in July 2019. Key Informant Interviews (KIIs) were conducted with several focus groups of the different occupational groups. Information was gathered on required competencies, knowledge, skills, attitudes, and behaviors (KSABs). The Generic Competency Dictionary (GCD) issued by the Civil Service Commission (CSC) was used as a reference in the development of the competency models for the functional groups and positions.

Validation of the KII results and the suitability of the CSC-GCD shall be done at a national scale through the conduct of a **National Online Survey from October 14 to 23, 2019** on the **six (6) identified priority DepEd Occupational Groups, namely: Planning; Finance; Education, Library, & Archival; Legal and Judicial, Medicine and Health; and General Administrative Group.** Competency models shall be developed in FY 2019 for the said groups.

In this connection, all Heads of Offices in all governance levels are enjoined to **ensure, through the necessary issuances, that all permanent incumbents of the priority DepEd Occupational Groups under their supervision accomplish the online survey on or before October 23, 2019.** Furthermore, the following offices shall be responsible for the preparation of necessary issuances, coordination on survey administration, and monitoring of survey participation:

### Occupational Group: PLANNING

This group includes occupations concerned with the formulation, implementation and evaluation of long-range and short-range development plans, programs and projects. It also includes occupations concerned with research, analysis, evaluation and forecasting of economic facts; selection, collection, computation, verification, analysis, treatment, presentation and interpretation of numerical facts; management information systems requiring the application of computer and information systems, related principles and techniques; and planning, scheduling, control and implementation of production.

### Occupational Group: FINANCE

This group includes occupations concerned with the generation, allocation and management of government financial resources through a systematic and organized process of recording, examination and interpretation of financial records and reports; the evaluation, formulation and installation of accounting, auditing and management control systems; and budget evaluation, planning, forecasting and execution. It also includes occupations concerned with revenue, customs, tariff and treasury administration; cashiering; processing of financial claims, property appraisal; loan and assessment examination; assets liquidation; credit collection; and license inspection.

It also includes occupations involved in legal counseling; and investigation and prosecution of illegal, unjust and improper acts or omissions of any public official or agency.
