

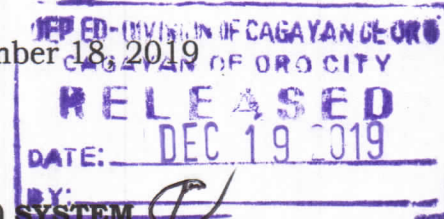



1. The Human Resource Development Division (HRDD), this Office, will conduct a three-day **Orientation to Learning and Development (L&D) System among Master Teachers** on January 29-31, 2020.

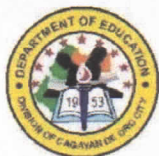


