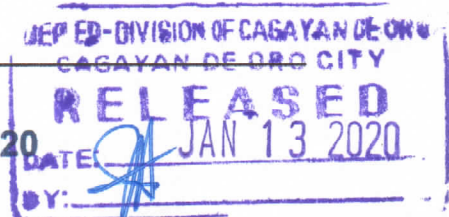

CONTEST MECHANICS & GUIDELINES:

1. The competition is open to JUNIOR HIGH SCHOOLS in Cagayan de Oro City. Only one entry/student per school is allowed to represent for the contest.
2. All entries/confirmation slip along with one valid school ID of the representative (ONLINE SUBMISSION VIA Google Form) or thru email must be submitted on or before **January 20, 2020** to **icalungsod@equalaccess.org**. Entries submitted late will not be considered
3. During the contest proper, each contestant will be given five (5) minutes to prepare his/her speech about the given topic. The speech may contain an introduction, body and conclusion. Questions may revolve on the summit's theme, objectives and activities. The contestant will be given three minutes to deliver his/her answer and will be evaluated by three judges using the criteria below.
4. Only top three (3) contestants and two (2) honorable mentions will be chosen as winners and will receive prizes and certificates during the summit's culmination program on **February 1, 2020**.
5. No fee required to join the contest.

1. The competition is open to SENIOR HIGH SCHOOLS in Cagayan de Oro City. Only one entry/student per school is allowed to represent for the contest.
2. All entries/confirmation slip along with one valid school ID of the representative (ONLINE SUBMISSION VIA Google Form) or thru email must be submitted on or before **January 20, 2020 to icalungsod@equalaccess.org**. Entries submitted late will not be considered.
3. During the contest proper, each contestant will be given 2 hours to write his/her essay about the given topic. Topics may revolve on the summit's theme, objectives and activities. The essay must not be over 800 words and written legibly. The contestants will be evaluated by three judges using the criteria below.
4. Winning entries will have a chance to be published or featured in EAI social media pages and websites.
5. Only top three (3) contestants and two (2) honorable mentions will be chosen as winners and will receive prizes and certificates during the summit's culmination program on **February 1, 2020**.
6. No fee required to join the contest.
