- Please be informed that a Clustered Teachers' Meeting will be conducted starting July 7, 2020. Matters in relation to the preparation for the opening of classes will be discussed.
- 2. Per IATF Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of July 2, 2020, Cagayan de Oro City is placed under Modified General Community Quarantine status. As such, as stated in Section 5, item No. 5 to quote: "Mass gatherings such as but not limited to, movie screenings, concerts, sporting events and other entertainment activities, religious services and work conferences shall be allowed provided that participants shall be limited to fifty percent(50%) of the seating or venue capacity". Hence, the conduct of face to face meeting shall further observe strictly the health protocols prescribed by DOH, such as:
  - a. wearing of face mask all the time;
  - b. maintained physical distance of 1.5 meters between participants;
  - c. temperature check taking; and
  - d. frequent Handwashing.
- 3. Attached is the initial schedule of the said activity for Southwest I, Southwest II, Central and South Districts.

- 4. A seat plan bearing the name, cellphone number and address of the teachers must be prepared by the host school in coordination with the PSDS to establish the identity of the teacher seated in a particular place to facilitate contact tracing when needed. Copy shall be forwarded to the SGOD Chief.

- 6. Immediate dissemination and compliance of this memorandum is directed.
