DEVELOPMENT AND ENHANCEMENT OF CONTINGENCY PLANS ON COVID-19 FOR IDENTIFIED CLUSTERED DIVISIONS

To: Assistant Regional Director

School DRRM Coordinators of the following SDOs:
Cagayan de Oro City, Camiguin, Gingoog City,
Iligan City, and Valencia City

- In view of the declaration of the state of public health emergency brought about by the COVID-19 pandemic, and in response to the enactment of the Bayanihan to Heal as One Act, the Department of Education (DepEd), through the Disaster Risk Reduction and Management Service, has developed various strategies in the implementation of its programs and activities to help address the health crisis.
- The DRRMS issued Supplementary Implementing Guidelines to the released OUA Memo-12-0220-0633: Implementing Guidelines on the Allocation, Utilization, Documentation, and Reporting of Program Support Funds for Disaster Risk Reduction and Management (DRRM), Climate Change Adaptation (CCA), and Education in Emergencies (EiE) Implementation.
- 3. The supplementary guidelines direct regions and divisions to utilize the funds allocated for the Development and Enhancement of Contingency Planning of Regions and Divisions that is included in the Disaster Preparedness and Response Program (DPRP) funds comprehensively released to regions, and where the amount allocated for divisions was then downloaded from regions to the divisions, not only for the development and enhancement of contingency plans on disasters, but also COVID-19 interventions.
- 4. In order to efficiently and effectively implement the development and enhancement of contingency plans for the divisions, the following Schools Division Offices (SDOs) agreed to simultaneously conduct the enhancement exercise as a cluster:
 - a. Division of Camiguin
 - b. Division of Cagavan de Oro City
 - c. Division of Gingeog City
 - d. Division of Iligan City
 - e. Division of Valencia City
