- All Education Program Supervisors (EPS) are hereby directed to facilitate in the development of K-12 learning resources in multi-media or digital formats such as eBook, radio-based instructions, video/TV episodes, and other multi-media/digital formats.
- 2. All concerned school heads are directed to free teachers as part of the development teams who have the technical background in radio and video production from the usual office and school work and other activities from July 20 to August 7, 2020. The task can be given as work-from-home assignment subject to existing policies and guidelines on alternative work arrangements of the Department.
- 3. All members of the Division TWG are directed to monitor the attendance of each talent and supervise the progress of each activity. Development team outputs shall undergo the usual regional quality assurance. The EPS shall submit the complete list of teacher talents in the LRMDS office.
- 4. Expenses to be incurred in the development and production of learning materials shall be charged to local funds or any available funds, subject to the usual accounting and auditing rules and regulations.

- This refers to the development of learning resources in audio, video, and other digital formats to be used in various learning delivery modes for various types of learners across the region. This endeavor is aimed at providing all learners with quality and accessible Self-Learning Materials (SLMs).
- The SLMs and other alternative learning delivery modalities must be ready before the opening of classes for SY 2020-2021 to address the needs, situations, and resources of each and every learner and shall cover all the bases in ensuring that basic education will be accessible amid the present crisis posed by COVID-19.
- The Schools Division Superintendents (SDSs) and divisional education program supervisors are requested to develop learning resources in multimedia/digital formats. In consultation with the division education program supervisors, the LRMDS EPS will lead in the selection of materials to be converted into eBook, radio-based instruction, video/TV episode, and other multi-media/digital formats.
- The SDSs are directed to free the development team who are composed of the divisions' LRMDS EPS, PDOs, librarians, core group of the ICT coordinators, teachers in charge of school ICT units, teachers teaching computer subjects, illustrators, teacher-coaches of radio broadcasting, TV broadcasting, and other personnel who have the technical background in radio and video production from the usual office and school work and other activities from July 20 to August 7.
