To reiterate the MLESF quick count process and objective, please refer to the illustration below:



In providing our schools with a ready reference in encoding summarized or initially processed selected MLESF data, the Planning Service (PS) gave an option of using the Automated Summary Matrix Tool before encoding the data to LIS Quick Count. However, should the school decide to use their own consolidation tool or strategy, it should ensure that no delay will be made and that the data requirement in the LIS Quick Count is fully satisfied.

Likewise, to speed up the Quick Count, the PS provided an alternative strategy on encoding existing learners with unchanged basic information in the previous LESF and have been confirmed to enroll in the same school during the distribution of report cards. It is proposed that the information of these learners can be encoded in the LES Quick Count facility without needing a printed and accomplished MLESF. The new information required in the MLESF can be generated through various online platforms by previous or prospective advisers.

Pursuant to DepEd Order No. 32, 2021, titled Guidelines on Enrollment for School Year 2021-2022 in the Context of the Continuing National Public Health Emergency Due to Covid-19, specifically Section V.2.D. (Enrollment Quick Count Reporting), these Offices respectfully request all Regional Directors to remind their respective Schools Division Superintendents (SDSs) and Schools Heads (SHs) to speed up the daily reporting/updating of enrollment count using the LIS Quick Count Facility until September 17, 2021.

In connection to this, SDSs and SHs shall undertake the following:

- Confirmation of enrollment of existing learners using the Modified Learner Enrollment and Survey Form (MLESF) to be facilitated by previous advisers;
- Initiate contact with learners who skipped the SY 2020-2021 and encourage them to go back to learning;
- Daily encoding of enrollment quick counts in the LES Quick Count Facility;

- d. Initiate a serious and wide information drive about the procedures and protocols of this SY's enrollment.
