
- 2. For **Teacher II** and **Teacher III** positions, concerned School Heads are to designate a School Personnel Officer who will be responsible for posting the vacancies at three (3) conspicuous places within and outside the school premises from **October 03 to 24, 2022**. After which, he/she shall accept letters of intent with supporting documents from interested applicants.
- 3. Interested applicants from other schools in this division may submit their letter of intent to the concerned school heads. Deadline for submission of applications on or before 5:00 p.m. of **October 24, 2022**.
- 4. The designated School Personnel Officer will then conduct a preliminary evaluation of applicant documents on **October 25**, **2022** which shall generate a School Selection Line-up to be certified by the School Principal
- 5. Posting of School Selection Line-up will be from **October 26 to November 10**, **2022**
- 6. School Evaluation and Interview will be done by the School Selection Committee on **November 11-12**, **2022** at their respective schools. **DepEd Order No. 66**, **s. 2007** shall be used as basis for document evaluation and interview.
- 7. On **November 14, 2022**. The concerned School Heads are directed to submit the following documents to the Division Office:
  - a.) Selection Line-up
  - b.) Certification of Posting of Selection Line-up
  - c.) Rank List
  - d.) Minutes of Ranking
- 8. Final Evaluation of documents by the Division Human Resource Merit Promotion Selection Board (HRMPSB) together with the Chairman of School Selection Committee will be announced on separate memorandum.
- 9. For **Master Teacher I** (JUNIOR HIGH SCHOOL), all applications shall be forwarded to the Secondary School where the vacancy exists. The School Selection Committee headed by the School Principal shall be responsible for posting the vacancies in not less than three (3) conspicuous places in the school and conduct a preliminary evaluation of applicant documents, generating a School Selection Line-up certified by the School Head, observing the same timeline indicated above.
- 10. This Office promotes the Equal Employment Opportunity Principle (EEOP). Qualified candidates are welcome to apply regardless of disability, sexual orientation, gender, age, religion and ethnicity.
