1. Regarding the issued **Regional Memoranda Nos. 619 and 623, s. 2022** titled **Panrehiyong Pagsasanay sa Ortograpiyang Pambansa, KWF Manwal sa Masinop na Pagsulat, at Korespondensiya Opisyal**, the activities have been scheduled on November 18-20.
2. The participants' first meal will be dinner on November 17, and the last meal will be lunch on November 20.
3. Compensatory time-off (CTO) shall be granted to the participants for the training day/s that will fall on either holidays or weekends in accordance with the CSC and DBM Joint Circular No. 2, s. 2004.
4. About the minimum conditions for authorized official travels per DepEd Order (DO) 43, s. 2022, this Office reiterates the following provisions and the corresponding considerations in preparing the participants' written justification:
 - a. **Item IV.A.1.a The trip is highly relevant to basic education** – Republic Act 9155 otherwise known as The Governance of Basic Education Act of 2001. The workshop is consistent with the requirements of these policies.
 - b. **Item IV.A.1.b The trip is essential to the effective performance of an official or employee's mandate or functions** – target participants are division supervisors involved in the implementation of the Programs aforementioned. The workshop will capacitate target participants in performing their functions/duties in the implementation of the said programs.

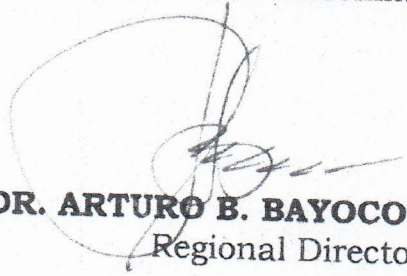
