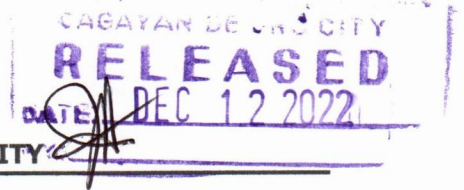

**CONDUCT OF THE DIVISION-WIDE YEAR END PROGRAM IMPLEMENTATION
REVIEW (PIR) OF MADRASAH EDUCATION PROGRAM (MEP- ALIVE) CY 2022**

1. In support to the issued DepEd Order 29, s.2022 titled **Adoption of the Basic Education Monitoring and Evaluation Framework (BEMEF)**, to guide DepEd operating units across governance levels in the conduct of Monitoring and Evaluation (M&E). The Cagayan de Oro division will conduct the *Division-wide Year-End Program Implementation Review (PIR) of Madrasah Education Program (MEP-ALIVE)* at South City Central School on December 19, 2022.
2. This activity aims to:
 - a. assess the implementation of the Madrasah Education Program among the 15 implementing schools vis-à-vis their commitment outputs and accomplishments for CY 2022;
 - b. identify issues and concerns that need to be addressed for the refinement of the future implementation of the program;
 - c. identify courses of action to be undertaken and provide necessary technical assistance to address concerns and issues in the implementation of MEP; and
 - d. share best practices and establish climate of excellence in the implementation of MEP in the Division of Cagayan de Oro.
3. The participants are the School Principals of the MEP implementing schools and the Asatidz.
4. All School Principals shall prepare a 5–10 minute powerpoint presentation and photo documentation (if there is any) of MEP implementation in their respective schools which include the following:
 - a. Enrolment: 1. Head Count and 2. Tagged in LIS;
 - b. Accomplishments vis – a – vis target on SIP / LRCP;
 - c. Challenges encountered in the implementation;
 - d. Best Practices;
 - e. Learning and Development;
 - f. Financial and Physical Accomplishment Report (if there is any); and





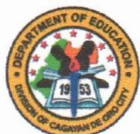
