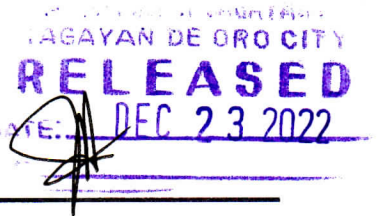

FOR GRADE 12 FOR SY 2022-2023



1. In view of Advisory dated October 27, 2022 on the Administration of the National Achievement Test for Grade 12 for SY 2022-2023 issued by the Office of the Undersecretary for Curriculum and Instruction, all concerned public and private secondary/senior high school heads are hereby informed of the administration of the said test. The test administration date shall be announced through a DepEd memorandum.
2. As the test materials were already received by this Office, we anticipate the test administration to be administered within the first months of the first quarter of 2023. As this is an exit assessment for the SHS curriculum implementation, all public and private schools offering the Senior High School curriculum shall participate in the said assessment.
3. Pending the issuance on the final date of the NAT G12 (BEEA) administration, all concerned schools offering SHS programs are directed to conduct necessary preparations to ensure readiness.
4. Concerned schools are strongly encouraged to conduct intensive remedial/enrichment classes for the Senior High School Least Mastered Competencies. Practice/simulation tests including shading the answer sheet and accomplishing the SDQ are also highly encouraged to acquaint the takers on the type of test to be administered.
4. An orientation shall be conducted to all school heads as chief examiners to be announced in a separate memorandum.
5. In adherence to Equal Opportunity Policy (EOP), inclusive and fair treatment are accorded to all concerned regardless of age, gender, sexual orientation, disability, religion and ethnicity.


**Administration of the National Achievement Test for Grade 12
for SY 2022-2023**

Attention:

Regional Testing Coordinators and Division Testing Coordinators

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) and with the assistance of the regional offices (ROs) and schools division offices (SDOs), shall administer the National Achievement Test for Grade 12 (NATG12) for SY 2022 – 2023. The test administration date will be announced through a DepEd Memorandum.
2. Through its forwarder, BEA shall facilitate the delivery of the test materials to the SDOs which shall commence this November.
3. The SDOs that already received their Basic Education Exit Assessment/NATG12 test materials in March 2020 per DepEd Order 033, s.2020 (*Administration of the Early Language, Literacy, and Numeracy Assessment for School Year 2018 – 2019, National Achievement Test for Grade 6 and Grade 10 for SY 2018 – 2019, and Basic Education Exit Assessment for Grade 12 for SY 2019 – 2020*) are advised to inspect the condition of the delivered test materials and communicate to BEA any concerns about the materials. These materials will be used in the upcoming NATG12 administration.
