FOR THE REBID OF THE PROCUREMENT OF OFFICE SUPPLIES AND CONSUMABLES FOR THE ARABIC LANGUAGE AND ISLAMIC VALUES EDUCATION (ALIVE) PROGRAM CY 2020 IN THE DEPARTMENT OF EDUCATION, DIVISION OF CAGAYAN DE ORO CITY ABC: 1,515,967.00

- 1. The Department of Education, Division of Cagayan de Oro City, through RA No.11465- FY 2020 GAA with fund code 01101101 to apply the sum of One Million Five Hundred Fifteen Thousand Nine Hundred Sixty Seven Pesos Only (Php 1,515,967.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Rebid of the Procurement of Office Supplies and Consumable for the Arabic Language and Islamic Values Education (ALIVE) Program CY 2020 in the Department of Education, Division of Cagayan de Oro City. Bids received in excess of the ABC shall be automatically rejected during bid opening.
- 2. The Department of Education, Division of Cagayan de Oro City now invites bids for the Rebid of the Procurement of Office Supplies and Consumable for the Arabic Language and Islamic Values Education (ALIVE) Program CY 2020 in the Department of Education, Division of Cagayan de Oro City. Delivery of the Goods is required upon issuances of Notice To Proceed as stipulated in the table below:

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, purstuant to RA No. 5183.

The Procuring Entity shall allow the bidder to present its proof of payment at the Cashier Section.

The Department of Education, Division of Cagayan de Oro City reserves will hold a Pre-Bidding Conference on January 27, 2021 @ 3:00 p.m. at the 2nd Floor canteen Building, Deped -Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the BAC Office, Ground Floor, DepEd Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City on or before 1:00 p.m. of February 8, 2021. Late bids shall not be accepted
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on February 8, 2021 at exactly 2:30 p.m. at the 2nd Floor, Canteen Building, DepEd = Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City. Bids will be opened in the presence of the Bidders' representatives who chooses to attend the activity.

The Department of Education, Division of Cagayan de Oro City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR f RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
