1. The *Department of Education, Division of Cagayan de Oro City*, through GAA-FY2020 with fund code 01101101 Flexible Learning Options (ADM/ALS/EIE) intends to apply the sum **One Million, Six Thousand, Six Hundred Sixty-eight Pesos (Php 1,006,668.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **REBID for the Procurement of Health Kits, Teaching-Learning Supplies and Materials for FY2020 of the Flexible Learning Options for Alternative Learning System (ALS) in DepEd-Division of Cagayan de Oro City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Department of Education, Division of Cagayan de Oro City* now invites bids for the **Rebid of Procurement of Health Kits, Teaching-Learning Supplies and Materials for FY2020 of the Flexible Learning Options for Alternative Learning System (ALS) in DepEd-Division of Cagayan de Oro City**. Delivery of the Goods is required upon issuance of the Notice To Proceed as stipulated in the table below:

Bidders should have completed, within **Five (5) years** from the date of the submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country under the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183.

4. Prospective Bidders may obtain further information from *Department of Education, Division of Cagayan de Oro City* and inspect the Bidding Documents at the *BAC Office, DepEd- Cagayan de Oro City, Fr. 

The Procuring Entity shall allow the bidder to present its proof of payment at the Cashier Section.

The *Department of Education, Division of Cagayan de Oro City* reserves will hold a Pre-Bidding Conference on **February 17, 2021 @ 3:00 p.m. at the 2<sup>nd</sup> Floor canteen Building, DepEd – Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the **BAC Office, Ground Floor, DepEd – Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City** on or before **1:00 p.m. of March 1, 2021**. Late bids shall not be accepted
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **March 1, 2021** at exactly **2:30 p.m. at the 2<sup>nd</sup> Floor, Canteen Building, DepEd – Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City**. Bids will be opened in the presence of the Bidders' representatives who chooses to attend the activity.

The *Department of Education, Division of Cagayan de Oro City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR f RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
