**Invitation to Bid for the**  
**Procurement of Works- Repair and Rehabilitation of 12**  
**Classrooms in the Department of Education, Division of Cagayan**  
**de Oro City: Cluster 1 – Pagalungan Elementary School (6**  
**Classrooms) and Iponan Elementary School ( 6 Classrooms )**  
**ABC: Php 2, 922,113.82**

1. The *Department of Education, Division of Cagayan de Oro City* through **R.A. 11518 – FY – 2021 GAA** with fund code **01101101** under the **BEFF – Rehabilitation, Renovation, Repair of School Buildings and Water and Sanitation Facilities** intends to apply the sum of **Two Million Nine Hundred Twenty Two Thousand One Hundred Thirteen Pesos and 82/100 (Php 2,922,113.82)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Works- Repair and Rehabilitation of 12 Classrooms in the Department of Education, Division of Cagayan de Oro City: Cluster 1 – Pagalungan Elementary School (6 Classrooms) and Iponan Elementary School (6 Classrooms)**. Bids received in excess of the ABC shall be automatically rejected during the opening of bids
2. The *Department of Education, Division of Cagayan de Oro City* now invites bids for the **Procurement of Works- Repair and Rehabilitation of 12 Classrooms in the Department of Education, Division of Cagayan de Oro City: Cluster 1 – Pagalungan Elementary School (6 Classrooms) and Iponan Elementary School (6 Classrooms)**. Completion of works shall be required **Ninety (90) Days from the receipt of the Notice To Proceed**. Bidders should have completed within **Five (5) years** from the date of the submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the Government Procurement Reform Act”. The contract shall be awarded to the Lowest Calculated and Responsive Bid (LCRB) who shall be determined as such during the post-qualification.
4. Interested bidders may obtain further information from the *Department of Education, Division of Cagayan de Oro City* and inspect the Bidding Documents at the BAC Office of the Department of Education, Division of Cagayan de Oro City, Fr. William Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City during weekdays from **8:00am to 5:00pm**.

5. A complete set of Bidding Documents may be acquired by interested bidders on **July 5, 2021 – July 19, 2021** from the given address below and *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5, 000.00).* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The *Department of Education, Division of Cagayan de Oro City* will hold a Pre-Bid Conference on **July 5, 2021 @ 10:00 a.m. through Zoom Video Conference** with **meeting ID: 821-0519-4956** and **pass code: gYZF74**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the **BAC Office, 2<sup>nd</sup> Floor, DepEd – Division of Cagayan de Oro City, Fr. William Masterson SJ Avenue, Upper Balulang, and Cagayan de Oro City** on or before **1:00 p.m. of July 19, 2021**. Late bids shall be grounds for disqualification.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **July 19, 2021** at exactly **2:30 p.m.** at the **2<sup>nd</sup> Floor, Canteen Building, DepEd – Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City**. Bids will be opened in the presence of the Bidders' representatives who chooses to attend the activity.
10. *Department of Education, Division of Cagayan de Oro City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
