II. CERTIFICATION OF QUORUM

Ms. Milagros Recamadas, BAC Secretariat certified that there was quorum to transact business after she acknowledged the presence of the Committee Members & bidders in attendance both physically and virtually.

III.BUSINESS PROPER AND HIGHLIGHTS OF THE CONFERENCE

Dr. Paraon requested the BAC Secretariat to present the overview of the electrification project.

Ms. Recamadas presented to the prospective bidders the ABC of the project per cluster since there are two clusters of the said project. Followed by Engr. Ariel Aranez, TWG who then discussed OUA Memo 13-0120-0599 dated January 23, 2020 in which he gave emphasis on the following:

1. Licensed Contractor of the PCAB with registration particulars SP-EE

(Electrical work) minimum Category A.

 Prospective contractors/bidders with PCAB license classification for General Engineering and/or General Building are not eligible to participate.

 Advised to secure the appropriate PCAB Registration Particulars on Electrical Works which is SP-EE, Category A or higher prior to participating in the project.

Dr. Paraon opened the table for the bidders on any clarifications and queries. The representative from CCO Construction Engineering asked about the process of the site visit. Engr. Aranez clarified that site visit is not a requirement, however, Engr. Mamaclay suggested that although site visit is not a requirement but they can check and see the identified site of the project. Mr. Sarip of Green builders also asked if there are changes in the memorandum issued in January 23, 2020. It was being clarified from the TWG that there was no changes.

Further, Engr. Aranez informed the prospective bidders to coordinate at the engineering section for the requirements for the service providers since CEPALCO and MORESCO differs on the required processes.

Having no comments and queries regarding the said procurement, Dr. Paraon instructed the BAC Secretariat to make some announcements and reminders as to next schedule of BAC meetings & conferences, especially the dropping and opening of bids.

The BAC Secretariat also give the timelines of the project.
