I. Call to Order

- Dr. Lorebina Carrasco, BAC Chairperson presided the Bid Opening Conference which officially started at 10:09am.
- Opening prayer was led by Ms. Loredelle Tacandong.

II. Certification of Quorum

- Dr. Carrasco requested the BAC secretariat to acknowledge the attendees including the participating bidders.
- Mrs. Milagros Recamadas called the roll based on the attendance sheet and presented to the Chairman for official quorum declaration.

- Dr. Carrasco certified that there was quorum and formally announced the project which the documents will be evaluated by the Committee.

III. Opening of Bids

- Mrs. Recamadas informed the Committee that there were two (2) bidders who dropped/participated for the project.

The Secretariat was requested to open the first envelope containing the technical eligibility requirements submitted by the participating bidders for the project: *Procurement of Works – Conversion of SPED Classrooms into Inclusive Learning Resource Centers at City Central School in the Department of Education, Division of Cagayan de Oro City (Phase 2)* with an ABC of Php 4,278,440.73 under Solicitation Number: 2022-066 and Reference Number: 9121937 in the PhilGEPS posting.

- The 1st bidding documents opened was from SS Construction & Supply of Amethyst St. Johndorf Subdivision, Barra Opol, Misamis Oriental.
- Copies of the technical eligibility documents were given to the BAC members who in turn have conducted thorough examination and evaluation of the documents. It was found out that all documents were in order, thus SS Construction & Supply was declared "PASSED".
- The Committee proceeded to open Financial Envelope with bid price of **Three Million, Nine Hundred Ninety-two, Three Hundred Fifty-nine Pesos and 73/100 (3,992,359.73) Only.**
- The 2nd bidding documents opened was from Green Builder and Enterprises of Tomarompong, Balindong, Lanao del Sur.
- Copies of the technical eligibility documents were given to the BAC members who in turn have conducted thorough examination and evaluation of the documents. It was found out that all documents were in order, thus Green Builder and Enterprises was declared "PASSED".
- The Committee proceeded to open Financial Envelope with bid price of **Three Million Five Hundred Seventy-five Thousand Fifty-eight and 86/100 (Php 3,575,058.86) Only.**
- The table showed the summary of the bid evaluation conducted.

- After the opening of bids, Dr. Carrasco, announced that the proposals will still be further evaluated by the TWG for approval of the BAC and the bidder with **the lowest calculated bids** will be notified of the results of the evaluation.




