CONTRACT AGREEMENT

Contract No. 2022-011

THIS AGREEMENT made this 30th day of MAY 2022 between **Department of Education, Division of Cagayan de Oro City** of the Philippines (hereinafter called "the Entity") of the one part and **TSM Food Products** of Purok 4B, Balindog, Kidapawan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Nutritious Food Products for the Supplemental School-based Feeding Program (SBFP) of the Department of Education – Division of Cagayan de Oro City SY 2021-2022: LOT 4 – Topical Fruit Juice of the Department of Education, Division of Cagayan de Oro City** and has accepted a Bid by the Supplier for the supply of those services in the sum of **Two Million, Five Hundred Fourteen Thousand, Five Hundred Sixty-four Pesos Only (Php 2,514,564.00)**, (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Two Million, Five Hundred Fourteen Thousand, Five Hundred Sixty-four Pesos Only (Php 2,514,564.00)** or such other sums as may be ascertained, **TSM Food Products** agrees to *Supply and Deliver for the Procurement of Nutritious Food Products for the Supplemental School-based Feeding Program (SBFP) of the Department of Education – Division of Cagayan de Oro City SY 2021-2022: LOT 4 – Tropical Fruit Juice* in the Department of Education, Division of Cagayan de Oro City in accordance with his Bid.
4. The **Department of Education, Division of Cagayan de Oro City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The Works referred to this Contract shall be executed within the contract duration of **60 days**, which shall commence on JUNE 6, 2022, and not earlier than the date of receipt of the Notice to Proceed.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


