II. Certification of Quorum

- Mr. Angelito Felisilda called the roll based on the attendance sheet and presented to the Chairman for official quorum declaration.
- Dr. Audie Borres certified that there was quorum and formally declared the opening of bids to begin.

III. Opening of Bids

- Mr. Felisilda informed the Committee that this project has one lone bidder.
- The Secretariat was requested to open the first envelope containing the technical eligibility requirements submitted by the participating bidder for the project: *(Rebid) Procurement of Assistive Devices for the Conversion of SPED Classrooms into Inclusive Learning Resource Centers* with an ABC of Php 2,800,000.00 under Solicitation Number: 2023-060 and Reference Number: 9965197 in the PhilGEPS posting.
- Bidding documents from D. Michael Co. (DMC) Enterprises Corp. was the opened.
- Copies of the technical eligibility documents were given to the BAC members who in turn have conducted thorough examination and evaluation of the documents. . It was found out that all documents were in order, thus D. Michael Co. (DMC) Enterprises Corp. was declared "PASSED".
- The committee proceeded to open the Financial Envelope with bid price of **Two Million Six Hundred Thirty-five Thousand Pesos (Php 2,635,000.00) Only.**
- After the opening of bids, Dr. Borres, announced that the proposals will still be further evaluated by the TWG for approval of the BAC. Once the bidder pass the bid evaluation, they will be notified of the results of the evaluation.
- Further, he added that after detailed bids evaluation, the BAC will conduct a post qualification, per RIRR of RA 9184 to verify the authenticity of the documents submitted and presented during the Opening of Bids.
- Having other matters to discuss, the opening of bids for the procurement of venue, meals and snacks ended at 10:17am then proceeded to discuss on other matters relative to procurement
