# FOR THE PROCUREMENT OF THE CONSERVATION/RESTORATION OF GABALDON SCHOOL BUILDING AT KAUSWAGAN CENTRAL SCHOOL IN THE DEPARTMENT OF EDUCATION, DIVISION OF CAGAYAN DE ORO CITY

ABC: PHP 12,113,951.57

- 1. The Department of Education, Division of Cagayan de Oro City, through FY 2024 GAA intends to apply the sum of Twelve Million One Hundred Thirteen Thousand Nine Hundred Fifty-One and 57/100 Pesos Only (Php 12,113,951.57) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Conservation/Restoration of Gabaldon School Building at Kauswagan Central School in the Department of Education, Division of Cagayan de Oro City, Project Information Number 2024 007. Bids received in excess of the ABC shall be automatically rejected during bid opening.
- The Department of Education, Division of Cagayan de Oro City now invites bids for the above Procurement Project. Completion of the works is required One Hundred Eighty (180) days from the issuance of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Interested bidders may obtain further information from Department of Education, Division of Cagayan de Oro City and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders March 20 April 8, 2024, from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Ten Thousand Pesos Only (Php 10,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees at the Cashier Section.
- 6. The Department of Education, Division of Cagayan de Oro City will hold a Pre-Bidding Conference on March 27, 2024 @ 11:00 a.m. at Division Office Conference, DepEd-Division of Cagayan de Oro City.

- Bids must be duly received by the BAC Secretariat through manual submission at the Division Office Conference, DepEd Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City on or before 8:30 a.m. of April 8, 2024. Late submission of bids shall be grounds for disqualification.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on 9:00 a.m., April 8, 2024, at the Division Office Conference, DepEd-Division of Cagayan de Oro City, Fr. William F. Masterson SJ Avenue, Upper Balulang, Cagayan de Oro City. Bids will be opened in the presence of the Bidders' representatives who chooses to attend the activity.
- 10. The Department of Education, Division of Cagayan de Oro City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
