

- 1. The Education Support Services Division (ESSD) of DepEd Region X will spearhead the rollout of the Regional Training of Trainers for Career Advocates on Career Guidance Trends and Strategies on December 17-21, 2018, at a specified venue to be announced by the ESSD in a succeeding memorandum.

4. A division consolidated list of participants for the regional training based on the distribution of allocation below must be emailed at essd.regionx@deped.gov.ph on or before December 10.


