

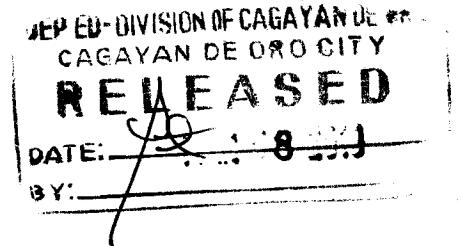

Greetings of Peace and Development!


