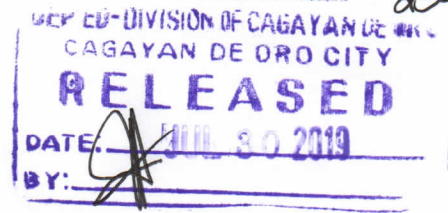

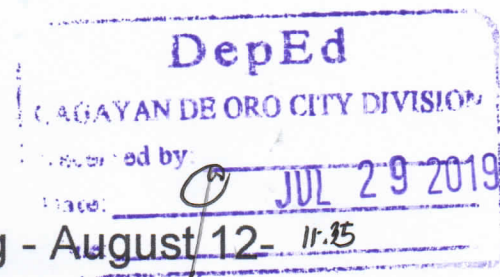

ADMINISTRATIVE NOTE

EXPECTATION

Participants who have successfully completed the training will be designated as Trainers on Cybersafety. As such, all participants are expected to have the leadership and training skills in order to cascade the training to other school and Division personnel. In addition, given that the discussions revolve around the online world, participants should be familiar with the Internet and social media.

The Cybersafety in Schools Training is one of the core components of the Child Protection Program. As such, topics on child online protection and related issues faced by children in the online world will be discussed. These topics may include sexual abuse, violence and other sensitive issues that may trigger or upset some people. All participants should prioritize their mental health and well-being and may opt not to participate in certain discussions or activities if the topics trigger a negative reaction.

All activities, workshops, and exercises are participative in nature and designed by the training team to facilitate adult learning experiences. These are done in the context of training, education, and raising awareness on child online protection issues.

SCHEDULE AND VENUE

The Cybersafety in Schools Training for Region X will be held in Deluxe Hotel, Captain Vicente Roa Street, Cagayan de Oro, Misamis Oriental on August 12-16, 2019. Participants for this batch will come from the Regional Office and all Schools Division Offices of Region X.

TRAVEL ARRANGEMENTS

Participants are requested to arrive on Day Zero, Monday, August 12, 2019 starting at 2:00 PM. The program proper will start on Day One, August 13, 2019 at 8:00 AM and will end on Day Three, August 15, 2019 at 5:00 PM. Participants will depart from the venue on Day Four, Friday, August 16, 2019.

Travel and incidental expenses of all participants shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.

All are advised to secure travel orders/authorities prior to attending the training. School-based participants are requested to arrange for work or teaching substitutes so that there will be no interruption in the daily classroom and school activities.

REGISTRATION

There will be NO REGISTRATION FEE collected for this training. Participants are requested to return the Confirmation Slip on or before July 31, 2019 to facilitate administrative and accommodation arrangements.

ACCOMMODATION

All DepEd participants and training management team members will be provided with hotel accommodation for four (4) nights on a triple-sharing capacity.

DATE: **June 24, 2019**

Pursuant to DepEd Memorandum No. 94, s. 2016 on "Promotion of Online Child Protection and Prevention of Cyberbullying", the Department of Education (DepEd) advocates for the protection of all children from online abuse, exploitation, and bullying through the use of the Cybersafety Lesson Plans for Grades One to Four, Grades Five to Six, and Junior High School. Developed through the partnership of DepEd and Stairway Foundation, Inc. (SFI), the lesson plans aim to develop children's capacities on how to be safe online, teach positive online behavior, and address safety issues as they navigate the online world.

To further the advocacy, the DepEd and SFI designed a training program for teachers and Division personnel on the use of the Cybersafety Lesson Plans.

Thus, the **Cybersafety in Schools Training** for Batch Region X will be conducted on August 12-16, 2019 in Cagayan de Oro City. The venue will be announced in a subsequent Memorandum.

Participants to this training shall come from the Regional Office and all Division Offices of Region X. The composition is as follows:

- From every Division:
 - One (1) DepEd personnel from the School Governance and Operations Division, specifically, the person-in-charge of Human Resources;
 - Two (2) Elementary School Master Teacher on *Edukasyon sa Pagpapakatao*; and
 - One (1) Secondary School Master Teacher on *Edukasyon sa Pagpapakatao*.

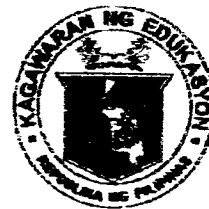
