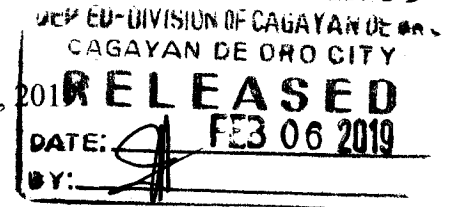

Attached is the communication from **ANICETA G. JABIGUERO**, Officer I, FSD and OIC Branch Manager, Government Service Insurance System (GSIS), Cagayan de Oro Branch, Cagayan de Oro City, relative to the non-payment of GSIS Financial Assistance Loan (GFAL) of some personnel of that Division for the months of July to September 2018 for any of the following reasons:

1. the deduction code of the foxpro program to effect the deduction was only available in August 2018;
2. due to computer technical glitch, the directory for secondary schools in both the Divisions of Cagayan de Oro City and Misamis Oriental were not prioritized by the system although corrected in the following month; and for salaries of the teachers were not sufficient to accommodate the deduction.

In view of this, division offices concerned are directed to advise the involved personnel to settle the unpaid amortization/s over the counter at GSIS to avoid further accumulation of interests and penalties.
