DATE: February 11, 2019

The Department of Education (DepEd) having the authority to exercise reasonable supervision over Private Schools, mandated the Regional Offices (ROs) to review and approved the application of schools for tuition and other school fees/charges within their respective jurisdiction.

In 2018, the Department issued **DM-PFO-2018-0649** re *Database on Changes in Tuition and Other School Fees/Charges in Private Schools*, which the main objective is to establish and maintain a database that will help the Department in tracking or monitoring the approval and implementation of increases on the abovementioned.

Relative to this, all Regional Directors are instructed to submit the list of private schools with approved tuition and other school charges/fees increase in the past three School Years by providing necessary information entailed in the electronic copy of the template that we will send through e-mail. Include also in the list those schools that have application for an increase but declined for approval.
