



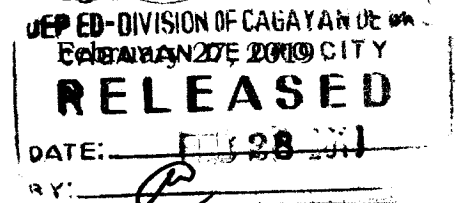

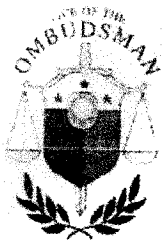

3. *Lapasan National High School*


