1. This Office, through the Quality Assurance Division (QAD), will conduct the **2019 1st Quarter Regional Monitoring, Evaluation, and Adjustment (RMEA)** at the Division of Lanao del Norte, on April 11, 2019. The pre-work will be at the Regional Office (RO) Conference Hall, on April 8, 2019 at 2:00 O'clock in the afternoon.
2. The conference aims to achieve the following:
 - a. Track and assess the implementation of DepEd policies and programs in the 14 Schools Division Offices (SDOs) for the 1st Quarter CY 2019;
 - b. Determine the efficacy and effectiveness of policy and program adjustments, if any, undertaken by the different functional divisions and units of the Regional Office (RO) to address policy and program bottlenecks and barriers across the 14 divisions during the 4th Quarter of CY 2018;

- c. Determine the needed policy and program adjustments to be undertaken by the RO to address performance gaps in ensuring MEA quarters CY 2019; and
 - d. Identify all other relevant steps to be undertaken by the concerned functional divisions to narrow performance gaps and enable DepEd Region X to meet its CY/SY 2022 performance targets and strategic goals.
3. Consistent with these objectives, the scope of the 1st Quarter CY 2019 RMEA shall be as follows:

a. **Focus:**

The purpose of the overview is to show the “big picture” describing overall Division performance in terms of **Enrolment**. (Early registration), **Net Enrolment Rate**, **General Enrolment rate**, **Achievement rate**, **drop out rate**, **survival rate**, **completion rate**, **graduation rate** if available, including **private schools**, and **Governance** of both. The Division needs **more focused** on **adjustment** in terms of **Regional Policy guidance**, **technical assistance**, **monitoring and evaluation**, etc.

The purpose of the overview is to show the “big picture” describing the overall divisional performance in terms of access and governance.

b. **Main Discussion: “Big Ticket” Concerns**

This part comes immediately after the overview. The SDO shall describe its “big ticket” concerns in implementing RO/CO policies and programs regarding access during the quarter. The presentation (from dashboards, segmentation, prioritization, characterization, and SWOT analysis) should provide a clear impression regarding the strengths and weaknesses of relevant RO/CO policies and programs in the succeeding periods.

4. Participants of this activity will be the schools division superintendents, assistant schools division superintendents, CID chiefs, SGOD chiefs, divisional Monitoring and Evaluation coordinator, one district






