

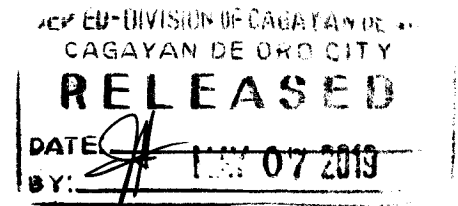

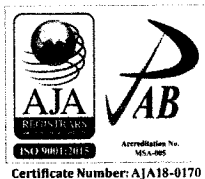

  - e. Best Practices and Achievements for the Past Three Years
  - f. Challenges and Venues for Improvement

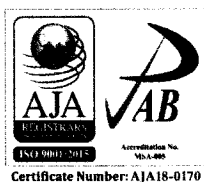

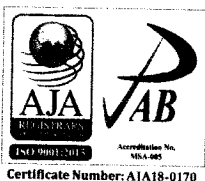
