



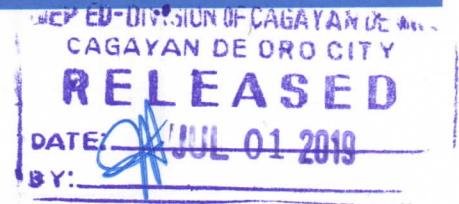

**UNIFIED IMPLEMENTATION OF THE PILOT PROJECT- COLEGA MANUAL
ON TEACHING THE RIGHTS OF CHILDREN FOR ELEMENTARY AND
SECONDARY SCHOOLS**

To : All Public Schools District Supervisors
All Education Program Supervisors/Learning Area Coordinators

All TWG members of the Colega Pilot Project

In consonance with the Division Memorandum No. 426, s.2019, all school heads are directed to facilitate and monitor the unified implementation of Colega Manual on Teaching the Rights of Children for SY 2019-2020. The Colega trainers shall conduct orientation and training to the identified elementary and secondary teachers who will handle the lessons 1-10. It is reiterated that all teachers who have received the Colega are required to utilize the manual for SY 2019-2020-2020-2021.

All public schools district supervisors, education program supervisors and learning area coordinators shall include Colega pilot project implementation in their monitoring and Instructional Supervision (IS). The IS reports relative to the pilot project shall be submitted quarterly through Dr. Joel D. Potane, Division ESP Coordinator.
