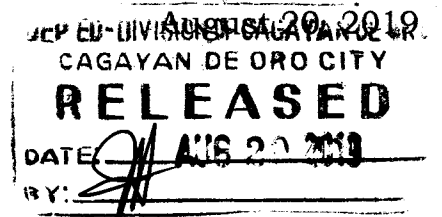

In light of this, it is desired that your Division will identify the six representatives, including the guidance counselor, who will attend and actively participate in the said summit.

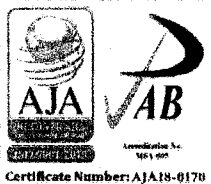

KAPIT-KAMAY: EMPOWERING THE YOUTH TO MAKE INFORMED CHOICES
(Summit to Discuss the Education, Health and Development
Dimensions of Early Pregnancy)

1. The Department of Education (DepEd) and the Department of Health (DOH), in coordination with other government agencies and nongovernment organizations, and as mandated by the Office of the President will hold the *Kapit-Kamay: Empowering the Youth to Make Informed Choices*, a summit to discuss the education, health and development dimensions of the issues on early pregnancy on August 22, 2019 at the Philippine International Convention Center (PICC), Pasay City, Manila.
2. The summit aims to:
 - a. Share information and data on early pregnancy, and understand its education, health and development dimensions;
 - b. Understand the risk and contributory factors to early pregnancy;
 - c. Identify common ground, existing interventions and formulate platforms or movement with diverse identities for stakeholders to continue policy advocacy and program implementation to address the concern.
3. The regional offices (ROs) shall select six representative learners, accompanied by one guidance counselor of the region with the following criteria:
 - a. 2 members of the Supreme Student Government,
 - b. 2 in-School Teen Parent (male and female),
 - c. 1 representative of Alternative Learning System, and
 - d. 1 representative of Indigenous People's Group or Special Education Classes.
4. Travel expenses and incidental expenses shall be downloaded to the ROs subject to the usual accounting and auditing rules and regulations.

5. Regional Directors and one representative each from the Association of the DepEd Directors Inc. (ADD), Philippine Association of Schools Superintendents (PASS), Philippine Elementary School Principals Association (PESPA), National Association of Public Secondary School Heads, Inc. (NAPSSHI); Philippine Public School Teachers Association (PPSTA), DepEd Medical Society (DEMS), DepEd National Nurses Association (DENNA), and Legal Officers and Attorneys of DepEd (LOAD) are enjoined to attend on official business. Travel expenses shall be charged to local funds.
6. Other participants to the event are out of school youths (OSYs), members of youth organizations, DepEd Central Office Bureau representatives, representatives of other national government agencies (NGAs), local government units (LGUs), Civil Society Organizations (CSOs), academe, and other private organizations.
7. The indicative Program Matrix is enclosed.
8. A separate memorandum shall be issued by the **Bureau of Learner Support Services** providing further details of the activity.
