The Philippine Overseas Employment Administration (POEA) launched the Illegal Recruitment-Free Local Government Units (IR-Free LGUs) campaign in 2006. The campaign seeks to intensify the nationwide campaign against illegal recruitment and trafficking in persons through sustained local action. It was undertaken with the cooperation between the Department of Labor and Employment (DOLE) and its attached agencies responsible for overseas employment program such as POEA and the Overseas Workers Welfare Administration (OWWA) and local government units. The campaign further supports the implementation by LGUs of their mandate under the Migrant Workers and Overseas Filipinos Act of 1995 (Republic Act No. 8042, as amended by Republic Act No. 10022). Under the said law, LGUs should take a proactive stance in combating illegal recruitment by undertaking information dissemination activities on all aspects of overseas employment and establishing local mechanisms to assist migrant workers.


In line with the above premises, the POEA would like to partner with the City of Cagayan de Oro and its barangays anti-illegal recruitment and anti-human trafficking campaigns. The campaigns will include activities such as Capability Enhancement Trainings for barangay officials and representatives of non-government organizations and the academe; anti-illegal recruitment/trafficking in person seminars for law enforcers and prosecutors. For this purpose, we would greatly appreciate if your local officials/employees, other local authorities and constituents could join these activities.

As a crucial partner in fighting illegal recruitment and human trafficking, the POEA and other DOLE attached agencies would also like to forge a continuing partnership and collaboration with the City of Cagayan de Oro through the signing of a Memorandum of Agreement (MOA) on IR-Free LGUs campaign with DOLE through its regional office, OWWA, POEA, and TESDA. Attached, for your consideration is the draft MOA detailing the objectives and scope of cooperation; the roles and responsibilities of the parties; and the institutional mechanisms for coordinating and monitoring implementation.
