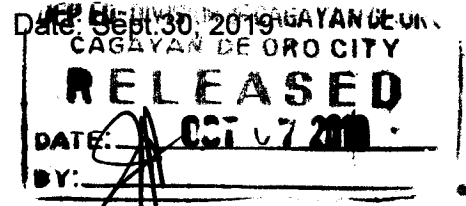



The Protocol for Case Management of Child Victims of Abuse, Neglect, and Exploitation was approved by the DOJ Committee for Special Protection of Children per Resolution No. 1 Series of 2013.

The Child Protection Committee of the 3 Public Schools (BES, KCS, KNHS) and 1 Private School (DMCC) is linked to the BCPC operational structure having a vital role in the system flow, thus we respectfully request participation of DepEd CDO Division Child Protection Officer together with the 3 Public School Principals with their respective Child Protection Committee (CPC) in the making of Systems Flow Manual for Barangay Kauswagan BCPC that will be functional and acceptable to the different conduit agencies (DepED, CSWD, PNP, CDO Judiciary, DILG)
