In reference to the issued National Memorandum No. 00343, you are hereby informed that there will be a nationwide English Proficiency Test (EPT) to be administered by the Bureau of Education Assessment (BEA) scheduled on **December 1, 2019, 7:00 A.M** at Fr. William Mastersons Elementary School, Upper Balulang, Cagayan de Oro City.
- 2. Applicants who were already in the ranklist during the last ranking and within the RQA who are not yet given permanent assignment are instructed to take, as well as teachers who are holding provisionary appointment for this purpose.
- 3. With this, all interested teacher applicant/ examinees are encouraged to write a letter of intent address to the Division Superintendent, through the Chairman of the Division Ranking Committee signifying their intension to take the test.
- 4. Deadline of submission is on or before November 22, 2019 at the Division Office-Receiving Section.
- 5. Failure to take the examination would mean disqualification to undergo the preliminaries of the 2020-2021 ranking process.
