The field is hereby informed about the Search for Best Documentary Video Presentation in I am HIPHOP (Honest, Industrious, Polite, Helpful, Obedient and Punctual) for SY 2019-2020. The search showcases various initiatives and versions of I am HIPHOP implemented in both public elementary and secondary schools effective August 2018 up-to-date.

The documentary video will be MPEG-4 file format and it should run only between five (5) to seven (7) minutes. If the presentation will be less or more than the allotted time, a deduction of one point shall be imposed. Only one (1) entry per school shall be considered for judging. All entries shall be properly indorsed by the Public Schools District Supervisors on or before November 15, 2019. Late entries will NOT be accepted.

The criteria for judging are as follows: (1) originality- 25%; (2) relevance of the created initiatives-20%; (3) impact- 20%; (4) creativity and technicality (sounds and visual effects and the flow of the presentation)-25%; and (5) time- 10%. The decision of the judges will be final and irrevocable.

The top 3 entries will be awarded during the 2019 CDO Seal Awards of Excellence.
