



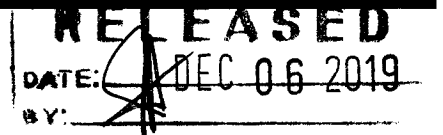




Travel and other incidental expenses of the participants shall be covered by the local Funds, subject to the usual government accounting and auditing regulations.
