

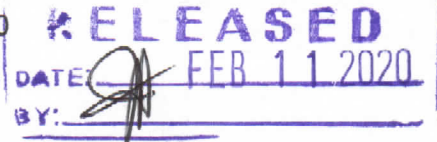

Journal-type format

The submission should have the following contents:

1. **Abstract** shall contain a maximum of 200 words. There shall be 3-5 keywords below the abstract. Keywords must be italicized.
2. **Full paper** shall not be more than 8,000 words.
(This number includes the list of references at the end of the article but does not include the abstract and 3-5 keywords. All texts shall be written in Arial, point 11, and single-space.)
3. **Introduction** shall contain the following elements: (a) research questions/research objectives; (b) review of literature which highlights only the most-up-to-date publications (2012 & above), except if necessary, to cite old literature/studies to give weight in the current undertaking; (c) the author can also add his interest in the research problem (state briefly)
4. **Methods** (research design, sampling, data collection and analysis, research ethics)
5. **Results and Discussion** (table which contains the data with in-depth analysis, interpretation, implications and literature support)
6. **Conclusion**
7. **References** (proponents shall double-check pertinent information required the writing style like page numbers, etc. Include only works cited (all in-texts citation) in the research paper.—APA 6th ed shall be observed
