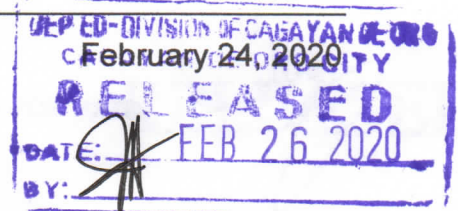

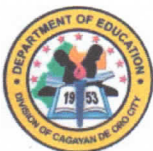

1. As the commencement of the Senior High School (SHS) draws near, a **Senior High School Expo and Job Fair** will be conducted from February 24 to March 13 with the theme "Ipakita at Ipamalas ang Galing, Kalidad na Edukasyon Kaya Nating Abutin."
2. The activity is aimed at achieving the following objectives:
 - a. Showcase the talents and skills of SHS learners; and
 - b. Ensure job placement of learners specifically those who intend to be employed after graduation.
3. The schools division offices are encouraged to conduct division/school-based expo and job fair and to observe precautionary measures on COVID-19 as stipulated in DepEd Memorandum No. 23, s. 2020.
4. The following activities for the SHS Expo shall be undertaken:
 - a. Product Expo (display of products);
 - b. Service Expo (demonstration of skills learned in the TVL);
 - c. Performance Expo (showcase of talents and skills); and
 - d. Learning Resources Expo (display of learning resources developed and redeveloped by learners).
5. The divisional SHS coordinators shall inform the Regional Office (RO) through the regional SHS coordinator Mr. Nick C. Pañares at 0917-771-9371, one week before the activity for monitoring and gathering of data.

7. Food, accommodation, transportation, supplies, materials, and other incidental expenses of the participants shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
