# **GRANT GUIDELINES**

## By the end of the American English Training of Trainers

- Propose a workshop to be offered for in-service or pre-service teachers in the next four months. The workshop should engage a minimum of 20 educators for a minimum of 4 hours.
- 2. Grant applicants must propose a workshop syllabus that is thoughtfully conceived and utilizes effective teaching methodology in its delivery of content to the participants.
- 3. The proposed workshop must utilize significant elements of "American English" teaching materials in either traditional or hybrid modalities.
- 4. Each proposed workshop can request a draft budget of up to PHP 15,000 per team member involved in the project. The draft budget should cover all needed elements of the workshop. Please note whether each budget item will be paid for by the U.S. Embassy and/or the host institution or other sponsor. Venue costs and honoraria will not be covered by this grant

## Two weeks after the AETOT workshop

- A grant application form detailing the finalized workshop plan must be submitted via email to <a href="mailto:mtrinidad@xu.edu.ph">mtrinidad@xu.edu.ph</a> on or before <a href="mailto:November 30">November 30</a>, <a href="mailto:2019">2019</a>.
- Along with the grant application form, the following must also be submitted as attachment:
  - a. A detailed budget that covers all needed elements of the program, noting which elements will be paid for by the grant and which will be provided by the host institution or other sponsor.
  - A letter of support from DepEd or the institutional supervisor and/or host institution confirming the location and dates for your workshop.

### Two weeks after completing the workshop/ re-echoing.

- Submit scanned copies of the following through an email to <a href="mtrinidad@xu.edu.ph">mtrinidad@xu.edu.ph</a>:
  - a. Attendance sheets
  - b. Photos from all major program activities
  - c. List of participants showing their age, gender, years of teaching experience, where they teach, what they teach (subject and grade), how many students they serve per day, and their phone and email address
  - d. Evaluations of the workshop and of the utility of the American English materials, with results tabulated and summarized with examples of exemplar and typical comments provided. Evaluation template will be provided.
  - e. Receipts for all claimed expenses
