

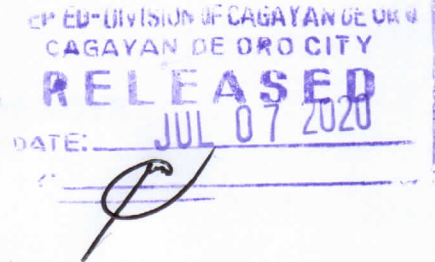

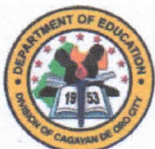

**QUALITY ASSURANCE OF K to 12 ALTERNATIVE  
DELIVERY MODE (ADM) MODULES**

To: Schools Division Superintendents  
Division Education Program Supervisors  
Elementary and Secondary School Heads and Principals  
All Others Concerned

1. In its commitment to ensure that all learners have access to quality basic education for School Year 2020-2021, the Department of Education-Region X, has developed Self-Learning Modules (SLMs) which will be quality assured by a pool of evaluators from the 14 Schools Division Offices (SDOs).
2. Hence, all members of the Regional Committee on Quality Assurance, Division Learning Resources Management and Development Education Program Supervisors, and illustrators in the SDOs are required to focus on evaluating the content, language, and design and layout of the SLMs.
3. The task can be given as work-from-home assignment subject to existing policies and guidelines on alternative work arrangements of the department.
