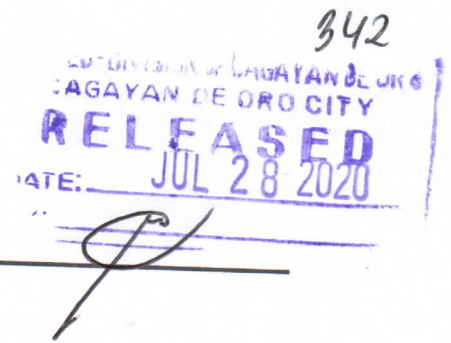

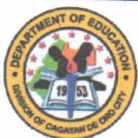

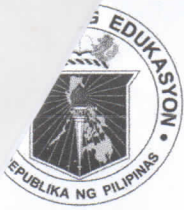

The Department issued **DepEd Order No. 7, s. 2020** (School Calendar and Activities for School Year 2020-2021) allowing private schools to open classes within the period authorized by Republic Act No. 7797 (An Act to Lengthen the School Calendar from Two Hundred [200] Days to not More than Two Hundred Twenty [220] Class Days) which is on the first Monday of June but not later than the last day of August.

To substantiate with data the ongoing efforts and preparations for the opening of classes, all **Regional Offices**, through the **Regional Planning Officers (RPOs)**, are requested to submit a list of private schools with **class opening that is earlier than 24 August 2020**. Moreover, the **Quality Assurance Division (QAD)** is directed to extend necessary assistance in identifying and preparing the requested list of private schools to the RPOs.

Kindly supply the needed information in the Excel template to be provided by the **Planning Service - Education Management Information System Division (PS-EMISD)** and submit through e-mail at ps.emisd@deped.gov.ph **on or before 27 July 2020**.
