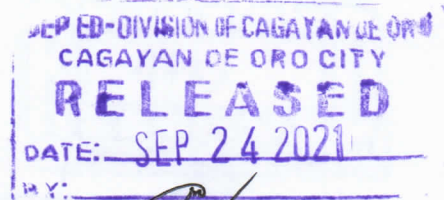

3. Immediate and wide dissemination of this memorandum is desired.

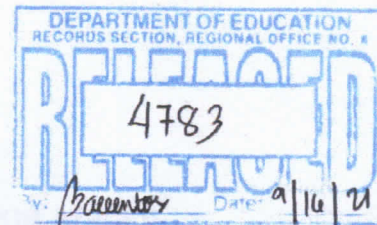

1. Consistent with DepEd Order 13, s.2019, or the Policy Guidelines on the Implementation of Enhanced Alternative Learning System 2.0, and DepEd Order 29, s.2021, or the School Calendar and Activities for School Year 2021-2022, this Office emphasizes the implementation of quarterly learning and assessment activities of ALS 2.0 for A&E Elementary and A&E Junior High School levels.
2. This implementation highlights the use of the ALS Assessment Form 1 or the Monthly Individual Learning Agreement (ILA) and the ALS Assessment Form 2 or the Monthly Monitoring of Learners Progress (MLP) to consistently track the performances of the ALS learners.
3. The learning and assessment activities for 10 months of the current school year are presented in the attachment while specific adjustments can be made by the ALS teachers for learners enrolled in the middle of the school year.
