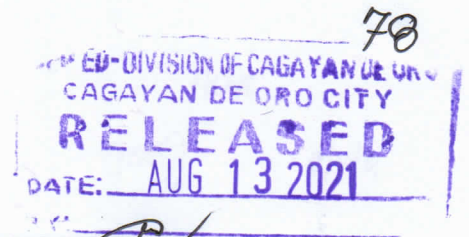

3. For your guidance and strict compliance.

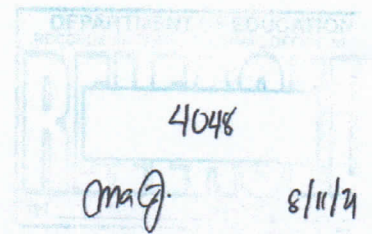

**2021 BIGATEN DEPED X SEASON 2 GUIDELINES: CLARIFICATIONS,
REITERATIONS, ADDITIONAL INFORMATION**

1. With reference to Regional Memorandum No. 375. s. 2021 on the **2021 BigaTEN DepEd X Season 2**, the following are reiterations, clarifications, and additional information to **Item F** on the **One-Minute News Reporting**:

- a. The Divisional Information Officers (DIOs) of the SDOs shall actively participate in the program! This segment, which started on August 10, will continue on August 17 and in the succeeding episodes.
- b. The DIOs shall present a **maximum one-minute news report** on any ongoing or recently conducted activity (within the week) in the division, district, or schools.
- c. To give reasonable preparation time for the DIOs and their teams, the schedule of the DIOs' news reporting shall be as follows:

Team 1 (1st and 3rd Weeks)

1. Bukidnon
2. Cagayan de Oro City
3. Camiguin
4. El Salvador City
5. Gingoog City
6. Iligan City
7. Lanao del Norte



Other videotaped news reports from the 14 SDOs, if there are any, will be accommodated on the fifth week.

- d. However, the SDOs that can probably produce and submit videotaped news reports on a weekly basis, if their schedules warrant, will be gladly accommodated.
- e. The DIOs may record their news reports in advance and email their outputs, at least, one day before the airing of the program every Tuesday. If the DIOs can guarantee a strong internet connectivity, they may also go live. However, they must inform the BigaTEN DepEd X Creative Force beforehand.
- f. In the absence of the DIOs, any of the School Information Coordinators (SICs) may be requested to present the news reports.
- g. The news reporters and their teams are advised to follow the one-minute requirement. The following are suggestions:
 - i. Shorten the INTRO and EXTRO video clips (e.g. animations and gimmickry) to avoid consuming the time allotted for the meat of the news report.
 - ii. Maximize the use of thumbnails.
 - iii. Employ the straight news type of reporting, which covers only the most essential information in a concise and impartial manner.
 - iv. Strike a balance in the use of clarity, conciseness, correctness, and creativity.
- h. The following is a **sample** template in news reporting:
 - i. Greetings: Magandang araw po / Maayong adlaw, mga Ka-DepEd!
 - ii. Details of the Straight News Report (5 Ws & 1 H)

- iii. Para sa BigaTEN DepEd XI _____, ako po si / kini si Ka-DepEd _____ mula sa / gikan sa Ozamiz City Division.
- iv. Slogan of the Division: _____
- 2. All other provisions in RM 375, s. 2021 remain in effect.
- 3. Immediate and wide dissemination of this Memorandum is desired.
