In addition, photocopy of the accomplished School OPCRf for the School Year 2020-2021 must be submitted on or before September 24, 2021.

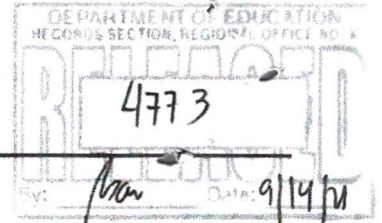
