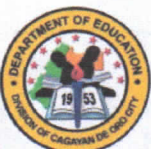

1. With reference to DM-OUCI-2021-316, or the Presentation Portfolio Assessment for ALS Elementary and Junior High School Program Completers of SY 2020-2021 and Previous Years, and after consultation with the division ALS focal persons and education program specialists for ALS (EPSAs), this Office strongly enjoins the field to perform transmutation of raw scores to percentages.
2. The presentation portfolio assessment is facilitated with the use of a point-system scoring rubric, which is very responsive to the ALS teachers and the learners.
3. However, this Office received inquiries from the formal schools and tertiary level institutions on the interpretation of the scores earned by the ALS program completers, especially as basis for college placement and admission.
4. Hence, the transmutation table is presented in the attachment. This transmutation is based on DepEd Order 8, series 2015, or the Policy Guidelines on Classroom Assessment for the K to 12 Basic Education Program.
5. Immediate and wide dissemination of this Memorandum is desired.
