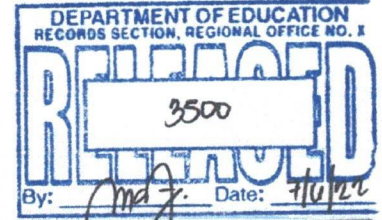

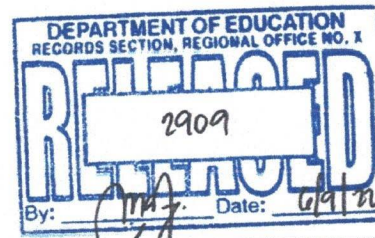

1. Following **Memorandum OM-OAGA-2022-059**, this Office will conduct a **Regional Mass Training of Alternative Learning System (ALS) Teachers on the ALS Act and its Implementing Rules and Regulations (IRR)** at NEAP Region X, Lapanan, Cagayan de Oro City, on August 1-13.
2. This training aims at the following:
 - a. Orient the ALS teachers to all the provisions of the ALS Act and its IRR,
 - b. Simulate the advocacy and social mobilization activities vis-à-vis the ALS Act and its IRR through an elevator pitch exercise, and
 - c. Present an action plan for the subsequent division-level training.
3. The participants of this training are all ALS teachers, education program specialists for ALS (EPSAs), and division ALS focal persons who are designated in clusters. Attachment No. 1 presents the clusters and the corresponding dates of the training.
4. Attachment No. 2 enumerates the names of the trainers and members of the Technical Working Group (TWG). There will be a prework conference for the trainers and the TWG on July 31 at the indicated venue.
5. The participants shall take with them a printed copy of the ALS Act and its IRR. The softcopies of these files can be accessed through the EPSAs.
6. In accordance with CSC-DBM Joint Circular No. 2, s. 2004, service credits are provided to the trainers and participants to cover Saturday and Sunday sessions. Hence, the participants shall submit three copies of the CS Form 48 and the accomplishment report to the authorized persons upon the completion of the training.

7. Further, the participants shall observe the IATF health and safety protocols for the entire duration of the training.

8. Training costs on accommodation, meals, supplies and materials, and other expenses will be charged against the downloaded 2022 FLO funds. However, the travel expenses and per diem of the trainers and participants will be charged against the 2022 ALS Program Support Funds (PSF), which will be downloaded directly to the SDOs, subject to the usual accounting and auditing rules and regulations.
