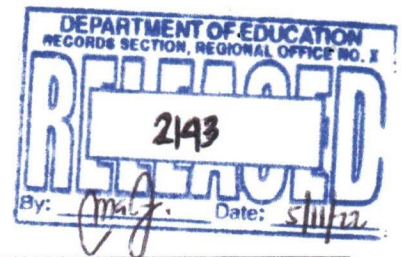



The Department of Education (DepEd) through the Bureau of Learning Delivery – Teaching and Learning Division (BLD-TLD) conducted a series of online workshops on the Development of Lesson Exemplar on Human Rights Integration in Araling Panlipunan for Grades 1 – 10 from April to June 2021 via Zoom app. Participants of the said activity were teacher-writers from 17 regions.

The activities aim to:
