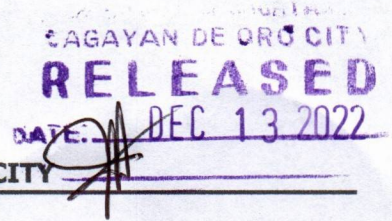

4. This Office directs immediate action of this Memorandum.

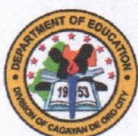

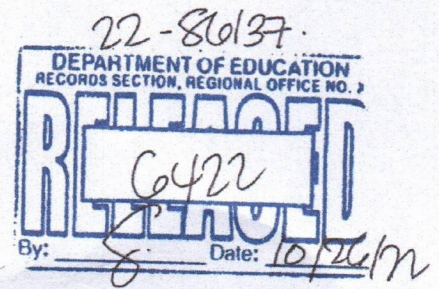
