This Office, through the Bureau of Alternative Education (BAE), will conduct a series of **Roadshows on the ALS Act and its Implementing Rules and Regulations (IRR)** starting on the 7<sup>th</sup> of February. With support from USAID, through the Opportunity 2.0 Project, the first leg of the roadshow will cover 12 project sites until the 18<sup>th</sup> of March 2022. Thereafter, the roadshow will be conducted in all the other regions.

The objectives of the activity are to: a) orient the participants on the salient features of the ALS Act and its Implementing Rules and Regulations; b) define the roles and responsibilities of different DepEd governance levels in the implementation of the law; and c) gather the commitment of both DepEd field officials and personnel as well as stakeholders in the community for the operationalization of the ALS Act.
