



Greetings from the Cagayan de Oro City COVID-19 Task Force and Emergency Operations Center (EOC).

Regarding your letter requesting the local COVID-19 Inter Agency Task Force to facilitate inspection of Cagayan de Oro City Division's public schools, we would like to invite you and your team to the Task Force's online meeting on March 24, 2022 (Thursday) at 3:30 pm. We request that your team present the **overall implementation plan** of engineering and administrative protocols for COVID-19 prevention during the face-to-face classes.

Also, we would like to

- know the designated safety officers per school
- know school contingency plans in case of escalation of Alert levels and rise in COVID-19 cases in schools
- be apprised of the Dep Ed memorandum/a that guide school face to face opening as well as be clarified on the need for a presidential declaration approving school opening.
- 4. know the vaccination coverage of teachers, non-teaching staff, and students/pupils.
- 5. have a list of names and addresses of the public schools in your division
- 6. have the list of contact person and his/her cellphone number for each school.

We suggest a Zoom meeting between our inspection team headed by Dr. Jan Sherwin Samong and representatives of/a few of your school principals prior to actual inspections to discuss schedules and possibility/difficulty of covering all schools by your target date.

We will contact by telephone your person in charge so we can agree on the date and time for the Zoom meeting between the inspection team and the school principals. We suggest this happens before the Task Force meeting on Thursday afternoon. We will send to you the Zoom link. A follow up meeting with most public elementary and secondary school principals will be scheduled.

Looking forward to you and your team's presence online on March 24, 2022, during the COVID-19 Local Task Force meeting. There is no need to present each school plan. Dep Ed X Cagayan de Oro City Division's overall School Opening Implementation Plan will be enough. We have allocated 30 minutes for this presentation and ensuing discussion.
