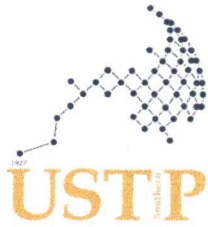

Greetings!




Dear Ms. Salem:
