4. Immediate dissemination and strict compliance of this Memorandum is directed.

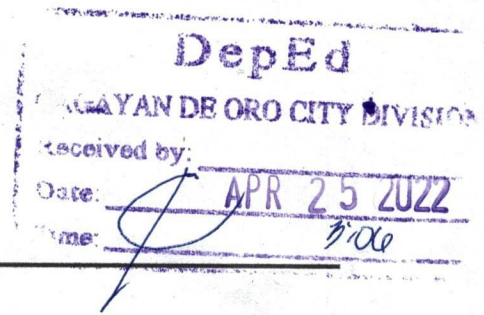


